



Milwee Middle School Band 2020-2021 School Year Instrument Contract

The Milwee Middle School Band and the school board of Seminole County are providing your child with an instrument to use during the 2020-2021 school year. Please read all the information carefully so that our instruments remain in good working order for the future. **You are responsible for the care and upkeep while it is in your possession.**

Seminole County will take inventory during the school year. At that time, all school-owned instruments must be returned immediately, and they will be returned to the student when inventory is complete.

1. We agree that if the instrument or case is damaged while in our possession, we will pay the amount for damages.
2. We agree that no other persons will handle this instrument (i.e. friends, brothers, sisters, etc.). This will help to prevent accidents.
3. We agree to pay the current price of the instrument, in the event of theft, loss, or extreme damage, rendering the instrument unplayable.
4. We agree to return the instrument, upon request, to the band director or proper officials.
5. We agree to return the instrument before the end of the school year. Students will be notified of the return date.
6. **We agree to pay a rental fee of \$150 for the school year.** Instruments that continue to remain unpaid can be taken back by the director at any time.

The instrument rental fee is \$150 for the entire school year.

**You may choose to pay \$75 by October 19, 2020 and \$75 by January 31, 2021. OR
If you wish to pay in full by October 19, please accept a \$25 discount. (Check total will be \$125)**

ALSO! If you are enrolled in weekly private lessons, please also accept a \$50 discount. This discount is contingent on the student continuing with private lessons throughout the entire school year. If you plan on starting lessons, please speak with Mr. Autrey to receive this discount. (Total will be \$75 or \$100)
